ENTRY FORM DEADLINE: 8:00 PM, Wednesday, March 15th

TOURNAMENT ENTRY FEE: \$15.00 per entry

ADMISSION: \$15.00 entry fee for all non-tournament participants (5 and under free) If a boxer is not entered in the tournament, he or she must pay.

AGE DETERMINATION: To advance to the National Tournament, a Senior Open Boxer **must** be between the ages of **17-40 before the first day of the Detroit Golden Gloves Tournament.**

PASSBOOKS: Boxers must have a 2017 registration card in their passbooks

REGISTRATION: "NO BOOK NO BOX" All coaches must be **Registered and Certified for the 2017 year** with USA Boxing If the coach is not **Registered and Certified** he or she will not be allowed to work their boxer's corner. If a coach is not **registered**, the coach must pay the \$15.00 admission fee (No Exceptions). **You must Register your boxer online. Go to usaboxing.org to register with USA Boxing.**

Uncontested Boxers: The Detroit Golden Glove Franchise reserves the right to deem an "UNCONTESTED" boxer "Unqualified" to travel with the Detroit Golden Glove team to the National Golden Glove Tournament.

Competition Wt. ins: Friday, March 31st - 4:00pm - 5:30 pm
Saturday, April 1st and April 2nd – 8:00am – 10:00 am

Only those boxers who are scheduled to compete on that day must weigh in. All Open class boxers' must make their "DECLARED" Weight. "Open" class boxers will have until the end of the weigh-in period to make weight. Any "Open Class Male" boxer who weighs in to compete and weighs more than two pounds of his declared weight may be automatically disqualified.

PHYSICALS: After the competition weigh-in time depending on the Doctor's arrival

WEIGHT DIVISIONS: Per USA Boxing rules

CLASSES: Juniors Per USA Boxing rules
Sub Novice 0 - 4 bouts - boxers may compete as a Novice or open boxer
Novice 5 - 10 bouts - boxers may compete as an Open boxer
Open + 10 bouts -There is no minimum number of contested bouts required to compete as an Open Class boxer.

If a boxer has "Any" contested MMA bouts he must compete as an "Open Class" boxer.

The Detroit Golden Gloves **"WILL NOT"** contest any **"Master"** bouts.

LENGTH OF ROUNDS: Per USAB rules time allowing

The Boxer, Coach, or the Guardian must fill out the weigh-in card; this will be the "Official Declaration" of the boxer's Wt. and boxing class. There will be "NO" changes at the tournament site.

The Detroit Golden Glove Franchise reserves the right to deem an "UNCONTESTED" boxer unqualified to travel with the Detroit Golden Glove Franchise team to the "National tournament".

I further hereby authorize competent medical physicians to furnish such medical and surgical treatment including anesthesia to me considered necessary and proper in the treatment of myself. It is also understood that this authorizes the hospital of the physician's choice should it to deemed necessary that I should receive treatment at the hospital.

I understand and agree that any medical or other services rendered to me by or at the instance of any of the named parties are not an admission of liability to provide or continue to provide any such services and is not a waiver by any of said parties of any right or rights herein.

I certify that I am in good physical condition, that I have had no head injuries or illness that I have sustained which may reoccur and be detrimental to my participation in this competition.
